Custom Work companies

- Organisational premium
- Work support premium
 - Salary premium
 - Coaching on the workfloor
- ~~Infrastructure~~



Organisational premium

- Quality standards
- Social services
- For PwLD and PSP: ($\text{€ } 663,26 \times \text{Contract} + \text{€ } 79,59 \times \text{Contract} (\leq 100)$) (max. capacity)



Work support premium

- **Salary**
 - 40% - 75%
- **Coaching**
 - 1 FTE per 13/10/7 PwLD

Work support premium is temporary!



- 10% will be evaluated
- Each 5 year new evaluation
 - Is WSP correct?
 - Is transition towards REC possible?

TRANSITION



Transition

- **4 steps:**


1. Intake (max. 1 month)
2. Jobmatching (max. 3 months)
3. Internship (max. 3 months)
4. Care (max. 3 months)

On average 140h


